Rules

- Open to anyone.
- Entry Fee is \$5.00 for the first item, then \$2.00 for additional items, this includes free admission.
- Entry form is due July 8th, 2009
- Show committee reserves the right to accept, reject, or reclassify entries.
- Must be clean and in show condition.
- Quilt entries must be brought to Patches and Petals 13 West Main St. Belleville, WI on Wednesday, July 15th between 10:00—6 p.m. Special arrangements may be made by calling Patches and Petals at (608) 424-1516.
- Quilts and prize money must be picked up Saturday, July 18th, between 4:30—6:00 p.m.
- Quilts entered in competition must be made by exhibitor.
- Quilt/Garment must be labeled on the left lower back with name, address, phone number and quilt name.
- Quilt must have a 4" sleeve secured to the back top of the quilt (except miniatures).
- Reasonable care will be taken to prevent loss or damage to entrant's property; however entrant agrees not to hold Belleville Chamber of Commerce and Patches and Petals responsible for any and all liability arising from any or all damage and loss to entrant's property. Quilters should have insurance if they deem it necessary.
- Signature on entry form implies acceptance of above rules. Entries will not be accepted without signature.
- Quilts may be shipped via UPS to: Lynn Alme, Patches and Petals, 13 W. Main St., Belleville, by Wednesday, July 15, 2009. Include with the quilt:

(1) A return label. (2) A check for \$8.00 plus \$.35 for additional insurance for each \$100 over \$100.

- Quilts that will be available for sale should have a 3" x 5" card completed with the owner's name, address and phone number along with the price of the quilt. The sale will take place after the show.

Divisions

Division A. Quilts quilted by commercial or professional longarm

- A1. Bed Size; any technique - minimum size 65" x 75"
- A2. Crib & Lap Quilts; any technique - minimum size 36" x 45"
- A3. Wall Quilt; any technique
- A4. Group Quilt, top made by 2 or more people, any technique

Division B. Bed Quilts (minimum 65" x 75")

- B1. Pieced or appliqué, hand quilted
- B2. Pieced or appliqué, machine quilted by maker, nonprofessional
- B3. Any other technique (tied, whole cloth, stenciled, embroidered, mixed, paper pieced, etc.)
- B4. Group Quilt, top made by 2 or more people, any technique

Division C. Crib & Lap Quilts (minimum 36" x 45")

- C1. Pieced or appliqué, hand quilted
- C2. Pieced or appliqué, machine quilted by maker, nonprofessional
- C3. Any other technique (tied, whole cloth, stenciled, embroidered, mixed, paper pieced, etc.)
- C4 Group Quilt, top made by 2 or more people, any technique

Division D. Wall Quilts

- D1. Pieced or appliqué, hand quilted
- D2. Pieced or appliqué, machine quilted by maker, nonprofessional
- D3. Any other technique (tied, whole cloth, stenciled, embroidered, mixed, paper pieced, etc.)
- D4 Group Quilt, top made by 2 or more people, any technique

Division E. Quilted Accessories

- E1. Tablerunner/candle mat
- E2. Home furnishings—any technique
- E3. Purse/Tote and accessories
- E4. Clothing—any Technique.

Division F. Youth

- Class 20. 12 and under—any item, any technique.
- Class 21. 13 to 16 -any item, any technique

Division G. Non-Judged – No Entry Fee— Any quilt that is not to be judged.

This will be a judged show. 1st, 2nd, 3rd place ribbons will be awarded for Divisions A through F.
